BORED ANYONE?

The terms of office of Jim Ferguson and Paul Hammond on the OCME Board of Directors end on December 31st, 2010. As of this printing there has been no one to volunteer to serve on the Club’s Board. There is a good chance that OCME will not have a Board of Directors on January 1st, 2011. Why? The OCME By-Laws state that the authorized number of Directors SHALL be five (5). It does not say that it would be nice to have five (5) or may have five (5) but SHALL have five (5). Our By-Laws also say that each Director SHALL be elected for a two (2) year term beginning January 1st. In case a Director leaves that office before his/her term is up the remaining Board members, by majority vote, shall

appoint an interim Director to fill the vacant position until the next election cycle. You can see by these By-Laws that we, as a Club, have to vote for Board members, we cannot appoint interim members just to get by a time hurdle.

Why is there a good chance that there will not be a Board of Directors on January 1st 2011? The Secretary of the Board has to mail an official ballot and an official ballot return envelop to each eligible member. These ballots have to be mailed to members no less than thirty (30) days prior to a special meeting when these ballots are counted.

For the good of OCME and for the future of OCME, would at least two (2) of our members make a commitment to serve on our Board of Directors.

Phil Parker



Phil was born in 1951 in Pasadena, California and for as long as he can remember, he's been fascinated by machinery and mechanical things that move. That's probably because his father was a bulldozer operator. From an early age, Phil would ride on his dad's bulldozers and in his trucks. This probably also has something to do with why Phil is more interested in motor sports than stick and ball sports. Anything that goes fast and/or makes a lot of noise, he's into it. Everything else is just a game!

Phil doesn't really remember when he caught the train bug. Seems like that's always been there too. It might have been the early train trips he and his mother would take in the summers to visit family in New Mexico. They would catch a Southern Pacific passenger train in Alhambra, California and the next

day they would arrive in Alamogordo, New Mexico. Those trips were like magic! It also could have been some of the railroad stories he heard there from some of his relatives who worked for the Southern Pacific out of nearby El Paso, Texas. Or it might have been that one Christmas, when he was 5 and he received his first Marx train set. A few years later, it was an American Flyer train set with a 4-6-0 Pacific locomotive with the chug chug sound and real smoke. If only he still had it! With that set, he and his father built their first layout on a 4' X 8' sheet of plywood. Then came his first HO train set. One that he bought with the money he saved up from a summer paper route. It was a Tyco with a Santa Fe GP 40. This time, Phil built the layout himself on the same sheet of plywood and it even included his HO slot cars. There's that motor sports thing coming in!

By now, Phil was about 13 and a lot of other things started to catch his attention. He and his family moved from Pasadena to New Mexico in 1965 but returned to Pasadena in 1966. Through his teenage years, he was an avid model car builder and had started playing bass guitar in a lot of local garage bands. He had also started racing his 1964 Chevy Nova at the original Irwindale Raceway in Irwindale, California. While trains weren't always on his mind, they weren't far away either. Especially since one of the main Santa Fe rail lines ran parallel to the drag strip.

Eventually, family obligations and the mundane task of making a living took center stage in Phil's life and he didn't have the time or the room to continue with the railroad hobby. But it still wasn't far away. He still read *Model Railroader*, and went to train shows and museums every chance he could.

For the past 34 years, Phil has worked in the title insurance business. He settled in Pomona, California in 1982 and married his wife, Joanie, in 2008. Right about that same time, he met Allen Stephens who works for the same company that Phil works for. After some conversation, Allen mentioned OCME and the trains. Phil and Joanie came down during the Fall meet in 2008 and that was it! They both joined and have been having a ball ever since. Phil keeps in close touch with a cousin who works for the Southern Pacific/Union Pacific conglomerate in Omaha, Nebraska. And he still has that original 4' X 8' sheet of plywood with some old HO track and ballast on it. Maybe someday...
